WHEREAS, The justice system in Mohave County has recently experienced security incidents which could have led to serious injury, loss of life; and

WHEREAS, There is a need for a committee on court security to establish long range plans and policies to meet future court and justice related needs in Mohave County;

IT IS ORDERED That the Mohave County Committee on Court Security is established as follows:

1. PURPOSE:

The committee shall serve as a forum to improve working relationships and communication as it relates to court security matters. The committee shall also be a mechanism to identify and effectively resolve security issues that impact the courts.

2. MEMBERSHIP:

The membership of the Committee is attached as an Appendix. The Chairman of the committee may appoint additional members as necessary.


3. MEETINGS:

Meetings shall be scheduled at the discretion of the Committee Chairman.

4. STAFF:

The Court Administrator's Staff shall provide staff support for the Committee and as feasible, may conduct or coordinate research as requested by the Committee.
